Veteran's Day Holiday Schedule 2017

- 1. Full-time Regular Schedule Employees. (FTR's)
 - 1. FTR's whose basic workweek includes Saturday as a scheduled workday will observe Saturday, November 11, 2017 as their holiday.
 - 2. FTR's whose scheduled off days are Saturday and a day other than Friday will observe Friday, November 10, 2017 as their designated holiday.
 - 3. FTR's whose scheduled off days are Saturday and Friday will observe Thursday, November 9, 2017 as their designated holiday.
- 2. Part-time Regular Schedule Employees. (PTR's)
 - 1. PTR's whose regular schedule includes Saturday as a workday will observe Saturday, November 11, 2017 as their holiday.
 - 2. PTR's whose regular work schedules do not include Saturday as a workday, but who are regularly scheduled on a **minimum** of five days in the service week, will have a designated holiday. This designated holiday will be observed on either November 10 or 11, in accordance with the same principles which apply to FTR's.
 - 3. PTR's whose regular work schedule does not include Saturday as a workday and who do not have a designated holiday by virtue of their not being regularly scheduled to work on at least five days in a service week are not eligible for holiday leave pay. However, if such PTR's regular schedule includes Friday, November 10, 2017 as a workday and they are precluded from working because the office is closed, the employee will be entitled to straight time pay for the hours of their regular schedule.
- 3. Part-time Flexible Schedule Employees (PTF's)

These employees are not eligible for holiday leave pay, as a holiday differential is included in their basic hourly rate of pay.

4. Mail Handler Assistants (MHAs)

Veteran's Day Holiday is not designated as a holiday for MHAs, as such they are not eligible for holiday leave pay for this holiday.

Holiday schedules must be posted by twelve noon (i.e., 12:00 p.m.) on the Tuesday preceding the service week in which the holiday falls.
