Q&As on the MOU: Re: Additional Mail Handler Staffing

Attached to this memorandum is a new MOU signed by the NPMHU and the Postal Service to provide for additional Mail Handler staffing by converting 2702 Mail Handler Assistants to full-time regular career employment no later than September 10, 2022. Also attached is a chart listing the 197 installations in which these conversions will take place and the number of conversions that will take place in each listed installation. The parties have also agreed in this MOU that the MHA peak season exception period for the 2022 peak season will be expanded by one (1) pay period.

Additionally, the parties have agreed to a Joint Question and Answer document addressing and affirming the parties' mutual understanding and interpretation of the provisions contained in this MOU, which is also attached.

## MEMORANDUM OF UNDERSTANDING BETWEEN THE UNITED STATES POSTAL SERVICE AND THE NATIONAL POSTAL MAIL HANDLERS UNION, A DIVISION OF LIUNA, AFL-CIO

Re: Additional Mail Handler Staffing - July 28, 2022

The parties agree to the following:

- 1. The Postal Service will convert 2,702 MHAs to career status in 197 installations as identified by the Postal Service, consistent with the attached table. The conversions will occur no later than September 10, 2022.
- 2. MHAs will be converted based on their relative standing on the MHA rolls within the installation. MHAs will be converted "in place" within the functional area they are assigned as of the date of this MOU and become unassigned in the 197 bid clusters identified in the attached table.
- 3. The MHA exception period for the 2022 peak season for exceeding the 24.5% limitation, as set forth in Article 7.1B3 will be expanded by one (1) pay period. This additional pay period must be adjacent to the two accounting periods previously identified to the Union under Article 7.1B3 for 2022, and the Employer shall notify the Union, at the national level and at the appropriate installation, of the selected pay period for each installation no later than August 31, 2022.
- 4. All conversions to career and separations of MHAs in accordance with this MOU will be done pursuant to the National Agreement.

## Questions & Answers for the MOU, Re: Additional Mail Handler Staffing – July 28, 2022

1. Question: Will the conversions to career status provided for in the Memorandum of Understanding (MOU), Re: Additional Mail Handler Staffing – July 28, 2022, count against the 1:4 or 1:6 ratios contained in the MOU, Re: Residual Vacancies?

Answer: No. The conversions to career status provided for in the MOU, Re: Additional Mail Handler Staffing – July 28, 2022, are not counted against the subject 1:4 or 1:6 ratios. The conversions to career status provided for in the MOU, Re: Additional Mail Handler Staffing – July 28, 2022, are in addition to those conversions to career status that result when the MOU, Re: Filling of Residual Vacancies, is applied.

 Question: What assignments will the Mail Handler Assistants (MHAs) who are converted to career status pursuant to the MOU, Re: Additional Mail Handler Staffing – July 28, 2022, be placed into?

Answer: The MHAs who are converted to career status pursuant to the MOU, Re: Additional Mail Handler Staffing – July 28, 2022, will be placed into the residual vacancies from the August posting based on their relative standing within the bid cluster/installation. Any MHA who does not successfully secure placement to a residual vacancy will be converted "in place" on or before September 10, 2022 as an unassigned regular equal to the number on the attached table.

3. Question: In the 197 facilities on the USPS provided table attached to the MOU, Re: Additional Mail Handler Staffing – July 28, 2022, will the MHA conversions result in the mail handler duty assignments being increased?

Answer: Yes: Duty assignments in those 197 installations will be over and above the current number of duty assignments. Any conversions to career status that result from residual vacancies listed in the regular eReassign postings will not count toward the subject 2,702 MHA conversions.

4. Question: Does any part of the MOU, Re: Additional Mail Handler Staffing dated December 23, 2020, the MOU, Re: Additional Mail Handler 1 Staffing - March 22, 2021, the MOU, Re: Additional Mail Handler Staffing - June 21, 2021, the MOU, Re: Additional Mail Handler Staffing - March 25, 2022, the MOU, Re: Additional Mail Handler Staffing - May 26, 2022, or the MOU, Re: Additional Function 1 Staffing - July 28, 2022, alter any part of the MOU, Re: Filling of Residual Vacancies?

Answer: No.

5. Question: For Installations that have insufficient MHAs for conversion, how will the conversions be filled?

Answer: There will be no direct hire into a career appointment. The recruitment will be to hire MHAs to fulfill the allocation. As soon as a MHA is hired and completes the orientation, the conversion will be effective the next pay period.
