According to the Postal Service, **the requirement for employees to use face coverings or masks continues when social distancing of six (6) feet cannot be maintained in public, or in public-facing settings when required by state or local orders or directives.**

Throughout the ongoing COVID-19 outbreak, the Postal Service has continued to fulfill its critical mission to bind the nation together. Postal Service employees are working hard across the country to ensure we are there for our customers every day, serving as a lifeline for millions of people.

As we are now in peak season, our mission is even more critical, and your safety and wellness are of the utmost importance. At the same time, we face unique challenges during peak season.

With an increase in staffing and an abundance of packages in our facilities, it is going to be increasingly difficult to maintain social distancing. So, we are urging you to have a face covering readily available when working and to wear a face covering whenever possible to ensure that you continue to protect yourself and your co-workers. If you do not have a face covering or if you require a new one, please request one from your supervisor.

The policy regarding face coverings has not been changed, rather it is being reinforced. The policy states that all employees are required to wear face coverings in the following situations, until the COVID-19 pandemic is no longer an issue.

- In public-facing settings when there is a state or local face covering order or directive in place; or
