## MAIL HANDLERS TO RECEIVE NEGOTIATED WAGE INCREASE

Effective November 24, 2018 - For career mail handlers, the basic annual salary for each grade and step of Table One and Table Two shall be increased by an amount equal to $1.3 \%$ of the basic annual salary for the grade and step in effect on May 20, 2016. This is the third of three-scheduled general wage increases as outlined in the 2016 National

Agreement. In addition to the general increases provided in Section 9.1, MHAs will receive an additional increase of $1.0 \%$ annually, for a total of $2.3 \%$ effective November 24, 2018, as specifically outlined in Article 9.7 of the 2016 National Agreement.
